**DRESSING 2017**

Warwickshire County Council proposes to make a Temporary Traffic Order closing the roads as indicated in the schedule below to vehicular traffic.

<b>Ilmington</b>	Back Street	From Front Street to Mickleton Road	26 – 28 April 2017	Front Street, Mickleton Road and vice versa

<b>Hampton Lucy</b>	Fullbrook Lane	From the junction with Corner Cottage to Hampton Lucy Road	28-30 April 2017	Via Snitterfield Street, Charlecote Road, Barford Road, Wellesbourne Road, Barford Bypass, Fullbrook Lane and Vice Versa
<b>Hampton Lucy</b>	Hampton Lucy Road	From Fullbrook Lane to the junction with Snitterfield Street	28 – 30 April 2017	Via Snitterfield Street, Charlecote Road, Barford Road, Wellesbourne Road, Barford Bypass, Fullbrook Lane and Vice Versa
<b>Bidford upon Avon</b>	Dugdale Avenue	From junction with Victoria way to end of road	27 – 29 April 2017	N/A Cul de sac
<b>Bidford upon Avon</b>	Elliot Close	From junction with Dugdale Avenue to end of road	27 – 29 April 2017	N/A Cul de sac
<b>Oldberrow</b>	Moreton Bagot Road	From the junction with Old Berrow Road to the junction of Wootton Wawen Road	25 – 27 April 2017	Via Old Berrow Road, Redditch Road, Hardwick Lane, Wootton Wawen Road and Vice Versa
<b>Combrook</b>	Combrook Road	From the river bridge (heading towards Fosse Way) to the brow of the hill.	03 - 05 May 2017	Church Hill, Combrook Road, B4086 Spring Hill, B4086 Bowshot Island, B4455 Fosse Way (and vice versa)

The closures are required for carriageway surfacing works.

The Order will commence on 23 April 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.
