- 1. This order shall come into operation on 24 October 2017 and may be cited as "The Warwickshire County Council (D5478 Compton Avenue, Bidford on Avon) (Temporary Prohibition of Traffic) Order 2017".
- 2. No person shall cause or permit any vehicle other than an exempted vehicle to use D5478 Compton Avenue, Bidford on Avon for a period of 18 months commencing on 24 October 2017, or until the said works are completed, whichever is the earlier.
- 3. In this Order exempted vehicle means any vehicle being used for or in connection with the said works.
- 4. The provisions of Article 2 above shall apply only at such times and to such extent as shall be indicated by traffic signs, as authorised by Section 64 of the said Act of 1984.
