ITEM 5 - SDC CONSULTATIONS

i. Draft Development Requirements Supplementary Document

There are some updates which council may wish to look at and comment on and there are 2 new sections:

- **a.** Part I Non residential buildings this looks at commercial buildings: their design and landscape and their impact on the neighbourhood.
- **b.** Part K Caravans and Holiday Lets this considers what is a holiday let/accommodation and their impact. Caravan sites and tourism go hand in hand and the policy aims to see how it can be controlled without impacting on the numbers visiting the district.

ii. Site Allocation Plan Reg 18

This consultation is very specific and appears to have limited impact on Bidford-on-Avon.

- a. Birthplace/Gateway Cultural Quarter (Stratford)
- **b. Quinton Rail Technological Centre** (Quinton and surroundings/railway)
- **c. A46 Safeguarding** although not directly in our area, it may be worth checking the impact on Bidford Roads and comment if appropriate
