2. NEW CHAIRMAN'S DECLARATION OF ACCPETANCE OF OFFICE

3. APOLOGIES FOR ABSENCE

Cllr. Sandle sent his apologies but is not feeling well. This was accepted. The Chairman took this opportunity to welcome back Cllr. Spiers who had been unwell for some time and in hospital. She added that he had been determined to come to tonight's meetings.
