Public Consultation on the revised Statement of Community Involvement

The Statement of Community Involvement (SCI) is a statutory document that explains to the local community how Warwickshire County Council will involve them in the preparation of planning policy documents (waste and minerals plans) and planning applications (relating to waste and minerals and planning applications submitted by or on behalf of the County Council).

The County Council adopted its SCI in 2005 and since that time there has been changes in internal governance/procedure (scheme of delegation). Additionally, the Localism Act 2011, National Planning Policy Framework (2012) and National Planning Policy Guidance further emphasis the need to involve communities. Therefore, the County Council has revised its SCI and now seeks your views during this consultation period.
