- The Chairman of the Communities WG explained that both the time line and the Steering Committee Structure were both dependent on the results of the Survey for the Community/Activity/Youth Centre Project and the recommendation was this should be noted
   RESOLVED to note that Timeline and Steering Committee Structure to be agreed after the survey has been carried out
- Draft Survey as Councillors had not had time to read this, it was proposed they should do this before virtual meeting with Andrew Maliphant on Monday and, if possible, send any suggestions to the Clerk before the meeting

**RESOLVED** Councillors to read the draft and let the Clerk have any proposed amendments for consideration at Monday's virtual meeting

#### Facilities WG

The only issue was the proposed gate to the track up to the Sports Pavilion. After a short discussion it was **RESOLVED** that the Chairman and the Chairman of the Facilities WG should meet in situ, agree the position of the gate and the disabled access to the toilet block: draw a plan and submit to Council.

**RESOLVED** to await plans drawn up after the visit and submit decision. The Emergency Covid 19 Group to make the resolution on the basis of the replies received.

Cllrs Knight and Taylor declared a personal interest and did not vote There followed a discussion regarding the wording of the application which was considered confusing:

- It refers to a "safe pedestrian access to Barton" but is a vehicular access from Welford Road
- It refers to "access to an existing vehicle charging point" which implies it is available to anyone driving along the Welford Road with the consequential traffic issues

The Clerk also advised that this vehicular access had already been reported to Enforcement and is awaiting a reply.

**RESOLVED** to object on the following grounds

- This has been reported to Enforcement as a vehicular access that has no permission: the "retrospective" application does not mention vehicular access but a "safe pedestrian access"
- It is not very clear what this application is for and until such time as the Parish Council gets clarity it will object.
